PLEDGE

We, the participants of the 67th Hokkaido University Festival (hereinafter referred to as Hokudai-sai) and the International Food Festival (hereinafter referred to as IFF), will promise the Chair of the Hokkaido University Festival Executive Committee (hereinafter referred to as Hokudai-sai Committee) and the president of the Hokkaido University International Students' Association (hereinafter referred to as HUISA) to adhere to 16 clauses written below during Hokudai-sai.

- 1. We will agree to and comply with the regulations and provisions set by the Hokudai-sai Committee and HUISA.
- 2. We will take full responsibility for any losses or damages related to the management of money and equipment.
- 3. We will NOT engage in any activities that involve profit organizations or are conducted for profit.
- 4. We will comply with the instructions from the Hokudai-sai Committee, Hokudai-sai Office, and HUISA, and will cooperate with them to ensure the smooth operation of Hokudai-sai.
- 5. We will complete the setup, takedown, and cleanup within the designated timeframe and restore the area to its original condition after our activities at Hokudai-sai.
- 6. We will make every effort to preserve the university's environment, facilities, and equipment.
- We will NOT engage in activities that violate public order and morals. Furthermore, we will NOT engage in aggressive solicitation or any actions that may harm other participants or visitors.
- 8. We will agree to the privacy policy of Hokudai-sai.
- 9. We will handle any personal information appropriately.
- 10. We will NOT submit false information to the Hokudai-sai Committee, Hokudai-sai Office, or HUISA. Furthermore, we will promptly report any errors or changes.
- 11. We will attend the General Assemblies which will be held 8 times by the Hokudai-sai Office and HUISA. In addition, the Fire Safety Manager and Hygiene Safety Manager will attend the Hygiene Safety Meeting as well as the Fire Safety and Rental Equipment Meeting. If the Fire Safety Manager or Hygiene Safety Manager is unable to attend for any reason, they must report to the Hokudai-sai Committee and Hokudai-sai Office (IFF Staff) and follow their instructions.
- 12. We will NOT use propane gas that is not purchased through the Hokkaido University Co-op.
- 13. We will NOT consume alcohol or smoke on campus during Hokudai-sai.
- 14. We will ensure that activities in Hokudai-sai are led by the Hokkaido University students and will NOT conduct activities based on the will of individuals or organizations outside the university.
- 15. We will immediately comply with any warnings, formal advisories, or orders—including temporary suspension or permanent termination of our activities—issued by the Chair of the Hokudai-sai Committee or the President of HUISA.
- 16. If we violate any of the 15 clauses listed above, we will fully comply with any decisions made by the Chair of the Hokudai-sai Committee or the President of HUISA.
